**RELEASE OF LIABILITY AND HOLD HARMLESS**

WITNESS THIS AGREEMENT this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between Green Meadow Farm LLC and Tracie Bjugan, hereinafter referred to as COMPANY and TRAINER, and \_\_\_\_\_, hereinafter referred to as RIDER/HANDLER. For consideration received, and in return for the use, today and on all future dates of the property, facilities and services of COMPANY and/or TRAINER, RIDER/HANDLER, RIDER/HANDLER 's heirs, assigns, and representatives, hereby agree as follows:

1. Inherent Risks and Assumption of Risk. The undersigned acknowledges there are inherent risks associated with equine activities such as described below and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of equines to behave in ways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant's ability.

RIDER/HANDLER acknowledges that horses, by their very nature are unpredictable and subject to animal whim. RIDER/HANDLER assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising therefrom. RIDER/HANDLER agrees to abide by and follow COMPANY's and/or TRAINER's rules and regulations. RIDER/HANDLER further acknowledges that the behavior of any animal is contingent to some extent upon the ability of RIDER/HANDLER. RIDER/HANDLER assumes all risks therefor and warrants a full and fair disclosure of RIDER/HANDLER's abilities has been made to COMPANY and/or TRAINER.

2. RIDER/HANDLER agrees to hold harmless, indemnify and defend COMPANY and/or TRAINER against, and hold harmless from, any and all claims, demands, causes of action, damages, judgments, orders, costs or expenses, including attorney's fees, whether actually incurred or not, which may in any way arise from or be in any way connected with RIDER/HANDLER's use of or presence upon the property of COMPANY and/or TRAINER and the facilities located thereon.

3. In the event RIDER/HANDLER is using RIDER/HANDLER's own horse, or a horse(s) not owned by COMPANY and/or TRAINER, RIDER/HANDLER warrants said horse(s) shall be free from infection, contagious or transmittable diseases. COMPANY and/or TRAINER reserves the right to refuse access or use of any horse upon the premises that does not appear to COMPANY and/or TRAINER to be in good health, or is deemed dangerous or undesirable.

4. RIDER/HANDLER agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.
