Gould Memorial REALTOR® of The Year award is limited to one time only for any recipient. (4) The current President is not eligible. Every other REALTOR® Member of the Association is eligible for consideration as the ROTY, unless they have received the award any year prior.

This award is based upon an individual REALTOR® member's contribution not only to the West Volusia Association of REALTORS®, but also to their fellow members, the real estate profession and to the community.
