I am writing to report a little girl of 2 years of age that I believe is being abused. Her name sounds like AP la Vay. ^(I do not know correct spelling)

I have been hearing, through a baby monitor, the interactions between her and her caretaker, Jules Leneo. I am not sure of the exact relationship between the two because the little girl calls Jules "Mom" but Jules has the little girl call her "Jules". (Probably adoption or foster care)

At first the abuse appeared to be psychological; however, now it has taken a physical characteristic.

I decided that I needed to tape what was going on so I have provided a tape. Only one side is recorded because I think I need to get this information to you. On side A, the first half of the tape is fairly hard to hear because of so much background noise. But starting somewhere around the middle, the tape is clearer. On the second half you can hear how Jules is relentless in her "lessons" to the girl who appears to be barely 2 years old.

Also, you can hear that Jules, who weighs something close to 300 lbs is sitting on the girl who probably weighs somewhere around 30 pounds. This is not for a brief second and the little girl is screaming & crying. Jules is trying to teach the little 2 year old to say "Get off of me, Jules". Alleway can mimic Jules if Jules says it a syllable at a time; however, Jules want her to say the complete sentence.

Alleway does not have that ability and she does not understand what is being asked of her. ^{And Jules won't get off of her.}

Furthermore, you can hear Jules teaching Alleway to say - "Alleway is stupid" and "Alleway is a chicken".

I have been listening to the baby monitor for at least a month now. The relentless lessons and cruelty have been the norm. The only times that Alleway has been treated with kindness is when someone ~~is~~ else is in the home, when someone is about to be in the home or when the family is about to be around other

people, I have heard Jules-Leneo say to Alleway "You like living at Jules' house because Jules gives you cookies". All of this tells me that Jules knows what she is doing is wrong and that she is trying to cover up her actions.

Other things that I have heard is Jules telling the little girl that she wished she did not have her. I have heard her tell the little girl to leave her house. Please keep in mind, this is a 2 year old. I am really worried about this girl's sense of security + well-being. Also, the little girl is in "timeout" much of the time. Timeout is a stint of playing by her bed in her bedroom. Someday she is in her bed more than she is up. Jules will tell Alleway that she won't talk to her until she stops crying. But when Alleway stops crying, Jules sticks her head into her room & says "I don't want to

talk to you". Eventually the girl stops crying. Julius will tell her that she does not want to talk to her & of course, the crying starts back up. This goes on for hours.

The other children in the home do not appear to be abused. At least, I do not hear it.

I hope that you will rescue Alleway. She really needs you. I am doing my part by writing to you but you must do the rest. Also, please listen to the tape. It sounds better if not played at full volume. Please hear through the first half & listen to the second half of side A.

You might consider coming out here & listening for yourself. Listen until Alleway goes to sleep at night, not just business hours. And listen for a month to get the whole picture. If it is illegal for you to listen, then hire someone who can do it legally.

UN IRE TAPE p. 1

On the tape:

(A) At the end of the tape, where Jules is sitting on the little girl, the harassment only stops after another child comes in the room and sees what Jules is doing to Alleway. You can hear Jules admit that Alleway is upset because she does not like her sitting on her.

(B) There are a couple of moments of seemingly caring for Alleway.

(1) Jules asks "Do you love me?"

and says "I love you" several times.

However, just seconds before she says "You are not allowed to cry. I'll put you out of my house". And it is followed by "Why are you crying? Turn it off".

(2) "Oh, Alleway, you are having a moment" in real sweet voice but then the usual badgering follows.

(C) At one point Jules says "I'm going to give you a shot because seriously I don't care at this point". I am assuming the girl is diabetic and has or something that she has a prescription for that shot. But I do not know for sure. Maybe.

① This little girl is endlessly in the situations that are on the tape, - she is made to repeat after Jules even when she is crying or not in the mood - she is made to spit out food & repeat after Jules during mealtimes - she is expected to act like an older child. The expectations for her are not age appropriate and neither are Jules' methods. I think Jules sees herself as a great disciplinarian but her methods are cruel and abusive. And, I believe that Jules knows that she is abusing Alleway. At the end of the tape when the ~~little girl~~ older girl catches her sitting on Alleway, Jules' voice changes to a slightly higher & friendly pitch when she talks to Alleway. Also, when Jules is telling Alleway to say "Alleway is stupid, Alleway is a chicken", the volume of Jules' voice goes down. I believe that is because she does not want the older children to hear her say these things to Alleway because she knows that what she is doing is wrong.

Tape 2

05/07/07

I started this tape last night when Jules had been harassing Alleway for a while.

Jules takes Alleway downstairs after a while, it is for a good while. I believe that she does this because there is another child, Abby, in the home. I leave the tape running during this period because I wanted to document how long she has the child downstairs. Usually, most of the harassment takes place in the kitchen or in Alleway's bedroom.

On the tape you can hear Jules tell Alleway that she will have to leave her home if she doesn't say what Jules wants her to say.

What you don't hear is the part where Jules re-enters Alleway's room after she puts her down to nap after the downstairs incident. Jules Allaps many times at Alleway to wake-up. This is re-

bursting screaming. Once she
has Alleway awake. The
harassment starts all over &
Alleway is told that she does
not get to eat dinner because
she won't say what Julie
wants her to say. I had to
turn the tape off so I do
not know how long this took
place or if Alleway was fed.
Also, the reason that I did
not record the screaming is
because I had put the recorder
up and I had to go get it again.
I know these tapes are
not well recorded. They are the
best that I can do.
Please rescue Alleway, Please.
