GMHA to increase rates by as high as 2,449%



Guamanians are looking at a whooping 12% to 2,449% rate increase for certain procedures and services at Guam Memorial Hospital Authority.

GMHA, the island's one and only civilian government hospital, in its Board Resolution on September 24, approved and adopted 14 new fees for Labor and Delivery, Pharmacy, and Operating Room. In another resolution though, GMHA wants to increase the rates of some 402 items in order "to meet its financial obligations, operating expenses, and capital improvement needs." The proposed rate increase would be from a low of 12% to as high as 2,449%. This rate increase exceeds the allowable 5% annual increase provided for under Public Law 22-66.

On August 21, GMHA conducted a Public Hearing on the 14 new fees. This was attended to by stakeholders to include representatives from health insurance companies. No attendees signed up for testimony, however.

On that same public hearing, the hospital's Board of Trustees provided the participants another list (402 items) of rate increase.

Frank Campillo of Selectcare stated during the hearing that the "huge rate increase would only affect the third party payers and not the non-payers that are the majority of the population." He added that the "impact would damage the system with less insured population and consequently increase the hospital's receivable."

On his August 26 letter to GMHA's CFO, Anthony Mendiola (VP of Staywell Insurance) states that "implementing the proposed 2015 Medicare APC fees at GMHA would lead to an average increase of 277%," further adding that "Increases in individual procedure code pricing ranged from 12% to 2,449%." He said that such increase would have a staggering financial impact. "For instance, the simple blood typing procedure that costs \$9.79 would be

Guam Memorial Hospital in hot water over client's garnished

tax refunds

laiming that Guam Memorial Hospital Administration ✓(GMHA) should collect from the Federal Government and not from her, an FSM citizen sued the hospital when the latter garnished her tax refunds to offset her unpaid

In the Class Action Complaint filed by a certain Tairin Asetom before the District Court of Guam on October 9, she states that she and her dependent children migrated to Guam as encouraged by the Compact of Free Association. She cannot afford to pay hospital bills as she is earning minimum or close to minimum wage, she was not offered health insurance by the companies she worked with, and she cannot afford private insurance. The complaint states that the Federal Government recognizes this plight as in the Compact, it obligated itself to reimburse the Government of Guam for the hospital bills. The Federal Government however, has not been reimbursing GovGuam as it should, causing now GMHA to garnish the complainant's (and other similarly situated) income tax refunds to pay their hospital bills.

The Compact of Free Association is likewise intended, as stated in its preamble to help the people of FAS achieve economic advancement and self sufficiency. But what happens, instead, to many of these people when they migrate here to high-rent, high cost of living Guam and start from the bottom, is squalor, and take the available minimum wage jobs, is they find that was little economic boost they had to look forward to by way of EITC refund is garnished by GHMA because the Federal Government is not doing its part and fully reimbursing GMHA for undesired but at times unavoidable and inevitably too expensive hospital bills they may incur for themselves of their children."

The complaint further adds GMHA should be turning to



the Federal Government for the hospital bills "these people simply cannot afford to pay."

The complainant and the "proposed class members," the intended beneficiaries of the Compact "have migrated here in reliance upon the Federal Government's expected good faith and fair dealing in implementing that Compact," the

The complaint also alleges that GMHA did not observe basic due process of notification of and an opportunity to be heard before the garnishment. GMHA was said to have garnished the complainant's tax refunds for the past 3 years "purportedly pursuant to 26 U.S.C. section 6402(e) as mirrored in the Territorial Tax Code."

Asetom and the proposed "class members" seek for declar-

atory judgment on whether GMHA can garnish their tax refunds. They also want the hospital to stop garnishing their tax refunds. Also, Atesom claims that the hospital bills she allegedly owes were mostly from 2007 and earlier and GHMA never instituted any collection lawsuit, thus the 4-year statute of limitations for doing so has already expired before the offsets at issue.

Defendants to the Lawsuit are GMHA, and Mr. Theodore Lewis in his official capacity as the hospital's Administrator. GovGuam was not included as defendant.

In an interview, Lewis states that the hospital is just doing what they have been doing even before he came into the picture. He added that the Compact issue is new to him and he himself is trying to understand its intricacies as it relates to the hospital./The Junction News Team

Guam Tax Commission to study delinking from IRC

Would the island benefit from delinking itself from the federal government's Internal Revenue Code (IRC)?

This is the question that the new Tax Commission has to find answers for as agreed upon by the members during their first meeting, October 13.

As there are too many concerns and issues that need to be addressed, the commission decided to take things one step at a time, and as Senator Mike Nicolas sitting as chairperson for the commission states, tax reform is a long and slow process. As such, the commission has not set a timeline as they want to make sure they want to accomplish something, learning from the mistakes of the previous commissions.

The commission decided not to take on tax reform issues just yet as they decided that the first step would be to determine the feasibility of delinking from IRC. Once this is issue is settled, then they can proceed on tax

And just as the commission is starting with their long and arduous task, there are already questions as to the impact of delinking. Vice Speaker BJ Cruz is concerned about its effect on Section 30. As chairperson for Committee on Appropriations and Adjudication, he wants to make sure that he will have source of funds, Section

30 being the territory's one major source of funds. He is also concerned of its impact on the Guam's triple tax exempt status.

As the commission members agreed to tackle delinking issue, Joe Bradley, SVP of Bank of Guam (representing Guam Bankers Association) said that a very small fraction of the IRC applies to Guam, adding "IRC is not designed for us."

Senator Nerissa Underwood on the other hand, states that there would be a need for a third party research to which Roseann Jones of University of Guam agreed they can help with.

San Nicolas said that to start, committees will be

formed and standing rules shall be drafted by his office. San Nicolas' office earlier on, prepared Tax Commission Working Archive, a more than a hundred-page collation of Guam's tax history, and the works of the previous tax commissions among others.

Present during the first meeting were Joe Arnett, Joseph Bradley, Roseann Jones, and Gary Hiles (as ex-officio member). The commission agreed to meet every first Tuesday of the month./The Junction News

In an effort to promote consumer protection, Senator Tommy Morrison introduced Bill No. 188-33 (COR) which, if enacted, would require the Contractor's License Board (CLB) to publish a list of contractors authorized to conduct business on Guam. The list would be published in print and electronically in a newspaper of general circulation (as defined by local statute) and will include information such as the Contractor's Name and Phone Number, CLB License Number, Identification of Responsible Managing Employee, and the Classification(s) of Work Authorized. The bill if approved, would require the list to be pushed annually. Additionally, the measure requires that individuals and companies performing work under the guise of a licensed contractor, shall be ordered to cease and desist from the violation, be assessed 50% of the value of the project, of which half would be used to compensate individuals affected – in accordance with CLB rules.

According to Senator Morrison, Bill No. 188-33

contractors published in response to growing concerns among Guam's law-abiding contractors of a serious issue involving unlicensed contractors. From illegal utility connections to unlicensed air-conditioning installation services, "there are folks in our community performing various work without the proper review and endorsements of the Contractor's License Board," states Senator Morrison.

Lawmaker wants list of

Since 2011, the CLB received 50 complaints involving unlicensed contractors. Guam law requires that no person within the purview of 21 GCA Real Property CH. 70 shall act, or assume to act, or advertise, as general engineering contractor, general building contractor or specialty contractor without a license previously obtained under and in compliance with this 21 GCA Real Property CH. 70 and the rules and regulations of the Contractor's License Board.


"I believe that the publication of a Contractors List is an additional way of helping our residents to navigate the difficult

and sometimes intimidating, process of choosing a qualified and experienced contractor. Moreover, the penalties proposed for unlicensed contractors will definitely contribute to ongoing efforts aimed at ensuring that our homes and other structures are built right, that people's hard-earned money are protected, and that illegal contractors are finally put out of business. People's lives are at stake," Morrison concludes.

Bill No. 188-33 (COR) is part of Senator Morrison's ongoing efforts to promote a level playing field for all law-abiding contractors. In anticipation of construction activity related to the military buildup, Senator Morrison says he is also in communication with Rear Admiral Bette Bolivar and her team regarding the application of local contractor laws to federal contractors performing work on non-military properties./The Junction News Team

GMHA CEO Accused of Abusing Hospital-Paid Credit Card

Amidst the controversies involving the only government civilian in the island, the CEO of Guam Memorial Hospital Authority is now in direct

rap.
This developed as Governor Eddie Baza Calvo issued a Memo to GMHA's Chairman of the Board Lee Weber asking the latter to conduct and investigation on the CEO's alleged misuse or abuse of his government issued credit card.

The October 12 Memo states that it was brought to the Governor's attention that Ted Lewis, GMHA Administrator/CEO allegedly dines using the hospital-paid credit card "almost every work day." It further adds that while the Governor understands "the need for a CEO to dine and entertain associates, especially investors or those he or she is dealing with, government administrators must be mindful of their fiduciary responsibilities. This is a more heightened concern for the hospital, which runs at a constant deficit because of its open-ended mandate." The Governor adds that "No one at GMH should be racking up thousands of dollars in

monthly restaurant charges on a government credit

Lewis for his part explained that it is necessary for his job to bring out his colleagues, mostly the doctors for dinner because these doctors are so busy and by spending an hour or two with them over dinner is an investment, most especially so with the presence of a competitor (referring to Guam Regional Medical City). He further adds that it is a practice that CEOs should build rapport with the doctors as they are a key asset to the hospital.

Lewis however belied allegations of "almost" daily dining as this is practically not possible, stating that he

is busy and the doctors are busy as well. On the average, he states that he dines with his doctors twice a week.

On the "thousands of dollars" restaurant charges a month, he states this is bloated. While there may be a month when the bill reached two thousands or thereabouts, that was when there were delegates that he needs to go out for dinner

Lewis, however, surprisingly does not know his representation expense cap, thus he does not also know if he spending within the budget./ The Junction News Team

Medicare Law a Disservice to Seniors





T he Medicare problem is one of the three most important things to resolve in 2006, though it should have been done years ago for the health and lives of Social Security (SS) members.

Here's a vivid story of a 65-year-old lady whose husband died last year. She's an SS retiree and is now living alone.

Her plight is of great human interest because she could be anyone. She's my good friend, Rose. Last week, she called from Manila where she is vacationing.

"Pat, I read through the PDN Web site that Medicare will reduce next year its support for Guam and 38% of doctors there may refuse to see us while others will do it as an act of charity."

"This will adversely affect 10,560 members and increasing on Guam," I replied.

"It pains me, Pat, because when they introduced Medicare in the 1960's, I was only 25 then and for 40 years I contributed 3% of my lifetime income. Now, I'm sickly and alone in life. Where's justice in America?"

"I'm so sorry, Rose. I wrote an article in the PDN seven months ago and followed up with series of articles in Mabuhay News calling for the amendment of the obsolete 40-year-old Medicare Law, but up to now all our politicians are silent on this."

"You know except for one or two, all politicians are created equal. They're known for their varied interest – people's interest, self-interest or supporters' business interest," Rose said.

"You're right."

"How I wish I got other private health insurance then because Medicare covers emergencies arising in Guam only. It's unfair; this should be changed."

"Yes. Besides, medical and dental costs in Manila are five and eight times cheaper respectively than in Guam and the mainland. Medicare and patients could save millions of dollars there. It's now globalized pricing for goods and services. Why are medical/dental services excluded?", I added.

"Got to hang up now, Pat, I have chest pains and must rest. I'll return to Guam in two days to get a doctor's referral there, then fly back to Manila again for my hospitalization."

She started to sob.

"Go now to Makati Medical Center. You're sick, Rose."

"I can't because I don't have enough money. Medicare won't pay for it because it requires that I be in Guam. Please continue working for the revision of Medicare's impractical provisions on emergency cases. That's one of our leader's promises, isn't it?"

"Yes, take good care of yourself. I pray that nothing wrong happens in your travel. I'll continue pursuing justice for SS members."

A week had already passed by.

No call or news from Rose yet. May God protect and bless my friend.

T he Manila Electric Company recently announced that it will reduce its overall rates for its residential customers by 13 centavos per kilowatt hour. That's six straight months that Meralco's overall rates have declined.

It's a welcome news for Meralco customers.

Guam Power Authority customers face a contrast reality.

There's an imminent increase of power rates.

Two power plants, the Cabras 3 and 4, in Piti were severely damaged as an explosion ripped off the roof shielding the two power plants.

It was reported that the damage caused by the outburst and fire could be at \$100 million. The agency says it could go as high as \$150 million.

The two power plants were constructed two decades ago. The power agency spent \$300 million in building these plants.

Although it has not been independently examined, GPA has stated that one of the power plants might have been extremely damaged and could no longer be repaired.

It would mean that it could cost the agency about \$200-\$250 million to replace the un-repairable power plant.

We should expect that the cost will be passed on to the

Catastrophic Leave Act Tax Cheat Gets One-Year Imprisonment Bill Signed Into Law $F^{ m or}$ failure to file income tax returns, supply infor-

Alegislation authored by Senator Frank F. Blas, Ir. that would create a Catastrophic Leave Pool Act has been signed into law by the Governor.

Public Law 33-76 is known as the "Catastrophic Leave Pool Act of 2015" and establishes a sick-leave pool for government employees who've been diagnosed with a catastrophic illness. Blas said this would allow an employee who has a catastrophic illness to receive sick leave from a pool, which would be an accumulation of donated sick leave time.

"This provides an opportunity to create a pool for those who want to donate their sick leave, but don't have a specific person to donate to," Blas said, adding that the law requires the Department of Administration to establish rules, regulations and definitions. The department will also maintain a "Catastrophic leave Pool" where donated sick leave hours will be deposited. There shall be no limits to the number of hours that can be donated to the pool.

Meanwhile, the Governor last month also signed Public Law 33-68, which is legislation Blas introduced regarding island Mayors and the zoning process. The law now allows municipal planning councils to review projects proposed to the Guam Land Use Commission and authorizes the Director of the Department of Land Management to include the mayors in the GLUC zoning and construc-

mation and pay required taxes for 3 years, a highly paid consultant of the A.B. Won Pat International Airport was sentenced to 1 year jail time, pay a fine amounting to \$22,500, and another \$343,950.00 in restitution.

Francisco Roberto Santos, on April 14 was charged with 5 counts of willful failure to file returns, supply information, and pay required tax. The information filed by the Attorney General's Office in behalf of the Government of Guam states that on 2008, Santos had a gross income of \$247,0778.85. On 2009, Santos had a gross income of \$254,238.54. His income for 2010 on the hand was \$251,967.86; on 2011 was \$249,600; and on 2012 was another \$249,600. In all instances, Santos did not file for tax returns and he failed to pay taxes.

On July 9, Santos entered a guilty plea to counts III. IV, and V (years 2010, 2011, and 2012 respectively). He said his gross income for 2010 was \$232,622; for 2011 was \$230,137; and for 2012 was \$229, 682. As such, for each count, he was facing a one-year imprisonment, fine of \$100,000 (maximum), \$25 mandatory special assessment fee, and one year

supervised release. He also agreed to pay restitution of \$343,950.00

Before the sentencing, high profile members of the community including two senators gave their support to Santos appealing that he was remorseful of his crime. and that the court should be lenient on him. Some even suggested community service in place of imprisonment.

Prosecutor Ioseph McDonald in his Sentencing memo reiterated the 3-year imprisonment. He said that Santos' tax crimes spanned 19 years. "From 1994 to 2012, Defendant willfully failed to file his income tax returns." "Defendant was first investigated in 2003 for failing to file returns for the years prior. When questioned, it was apparent that his failure was willful, in violation of a known legal duty. Defendant at that time made representations to DRT agent that he would file his taxes, alluding to his hiring a CPA for assistance, and asked that DRT afford an exception and provide business license to him so that he could file and pay his GRTs. However, Defendant failed to abide by his own representations. He never followed through with his CPA to file returns and never filed nor paid GRTs. In 2013, DRT tax agents questioned Defendant again. It was clear that Defendant took no action to remedy his own failures. He explained that he was too busy for the last 19 years to file his tax returns and that it was a burden on him.

The Defendant had the use and enjoyment of his money while the Government did not. While many low bracket taxpayers paid then waited months for their refunds, Defendant had full use and enjoyment of his

"In a time when the Government is fiscally tight, his crimes had significant impact, and other scofflaws' tax crimes have, too.

"Almost every islander is directly affected by the Guam Territorial Income tax Law. Congress recognized this and demands the highest mens rea found in the law before a citizen can be convicted of a tax crime: willfulness, that is, the intentional violation of a known legal duty. Unlike any other crime, even murder, ignorance of the law is an excuse. Tax crimes, therefore, involve a deliberate flouting of the law and obligations of citizenship.

"It is crucial ... that taxpayers believe that everyone is paying their fair share; they must perceive the

OPA Dismissed Maeda Pacific's Procurement

Appeal against GSWA

Doris Flores Brooks, public auditor of Guam of the Office of the Public Auditor or (OPA), recently signed the order of dismissal on the procurement appeal made by Maeda Pacific Corporation (MPC) against Guam Solid Waste Authority (GSWA).

The decision was made after almost three months of deliberation, appeals, motions and extensive review of the case of both parties (MPA and GSWA). Brooks finds the appeal presented before the OPA has something to do with money owed to or by the government of Guam and therefore the OPA lacks jurisdiction of the said appeal and that both parties were advised to seek a iudicial review of the case to the Superior Court of Guam.

Maeda Pacific Corporation (MPC) is a private contractor that was awarded with the Harmon Residential Transfer Station by Guam Solid Waste Authority (GSWA) in November 2012 under contract number GSWA-12-02 with contract amount of \$2,410,000.00 and to be completed after 308 days upon signing the agreement.

The dispute started when both parties (MPC and GSWA) are claiming breach of contract over the Harmon Residential Transfer Station. The MPC asserts that it is owed by GSWA the amount of \$506.483.39 as payment for the project. GSWA however assessed \$663,000 of liquidated damages against the MPC and asserts that the difference between the said amounts of \$156,516.61 is payable by the Maeda Pacific Corporation to Guam Solid Waste Authority.

The MPC which is represented by Phillip Torres of the Torres Law Group, appealed over the validity of the contract and the liquidated provision last August 17. The liquidated damages deemed by the GSWA has a total of \$3,300 per day for the breach of contract against the MPC for failing, refusing to finish the work in the time as specified in the contract. Under the same provision, the liquidated damages are assessed for each calendar day the contract took effect, that resulted in the amount of \$663,000.00 being demanded by GSWA.

The appeal to void the liquidated damages was filed before the OPA by MPC; however, hearing officer/ public auditor of Guam, Doris Flores Brooks said OPA does not have jurisdiction over the matter since there is money disputed by both parties involving the government of Guam.

Brooks in a resolution, advised both parties (MPC and GSWA) of their right to judicial review in the Superior Court of Guam of a decision of the Public Auditor under 5 G.C.A. Chapter 5, Article9 of the Guam Procurement Law. Both parties were given fourteen (14) days to either resolve the dispute on their own or present the case before the Superior Court of Guam./The Junction News

billed at \$76.07." Mendiola cited more examples such as code 31500 for insertion of emergency airway for which the current rate is \$5.09, will be increased to \$129.72 which is a 2,449% increase.

"As we all know, the changes will significantly impact the private payers and the consumers as well. Earlier this year, the hospital already implemented an adjustment in its fees. A gradual, rather than a sudden steep adjustment, is the approach that the community can work with.

"On the other hand, we question the appropriateness of applying the 2015 Medicare APC rates on Guam at this time. APCs or 'Ambulatory Payment Classifications' are the government's method of paying facilities for outpatient services for the Medicare program. This component of the Outpatient prospective Payment System (OPPS) for hospital outpatient services is analogous to the Medicare prospective payment system for hospital inpatients known as 'Diagnostic Related Groups' or DRGs. From our recollection, this system - including its required coding systems, rules and processes - has never been used at GMHA. Medicare itself may not use such a scheme with GMHA

at this time," Mendiola explained in his letter.

In the August 21 GMHA public hearing, Benita Manglona (GMHA CFO) emphasized that the cost of delivering healthcare has significantly increased over the years while GMHA rates have not kept pace of the increases. She said that the hospital "has not adjusted its rates since early 1990s" and that "current fees are not sufficient to cover operating costs," citing from the 2014 Office of the Inspector General report.

On October 12, GMHA submitted the proposed rate increase (and the new fees) for Legislative action. Senator Dennis Rodriguez, Jr. being the chairman for the Committee on Health, Economic Development, Homeland Security, and Senior Citizens filed Bill

No. 189-33 (COR) for such purpose. Rodriguez announced that a public hearing will be conducted on October 22 at 5:30 pm in the Public Hearing Room of I Liheslatura.

Vows to Wage 'Revolution' for Unity and Change

Senator Ferdinand "Bongbong" R. Marcos Jr., October 13, filed his certificate of candidacy for vice president in the May 2016 elections at the main office of the Commission on Elections (Comelec) in Intramuros, Manila.

In a statement, Marcos said this marked the beginning of his fight to eradicate poverty, clean the streets of illegal drugs and other vices and crimes, eliminate graft and corruption in the government, boost the economy, and unite the Filipino people in nation-building for a progressive society.

Marcos, accompanied by his family and several supporters, walked to the Comelec after he prayed at the San Agustin

On October 10 he formally proclaimed his vice presidential bid and vowed to wage a "revolution" for unity and change for a better Philippines.

"Sa tulong ninyo at ng bayan, pamumunuan ko ang isang rebolusyon sa puso, isip at gawa tungo sa isang tunay at makabuluhang pagbabago. Pamumunuan ko rin ang isang kampanya upang makamit natin ang ating mga pangarap sa buhay. Hindi ako makapapayag na mawala sa atin ang ilang bahagi ng ating bansa. Ipaglalaban ko ang integridad ng ating bayan," he said in a speech.

He said that in his 30 years in public service, he had seen the sufferings of the people and the inability of the government to extract families from abject poverty, selective justice, and blatant connivance of corrupt government officials and greedy private individuals to siphon off the country's wealth.



Mandaue City is APEC's latest low-carbon model town

onsidered the sixth smallest government unit in the Philippines in terms of land area, Mandaue City is now far bigger than anyone realizes.

On Tuesday, during the 12th Asia-Pacific Economic Cooperation (APEC) Energy Ministers' Meeting, Japan announced the selection of Mandaue as the APEC's latest Low-Carbon Model Town. (LCMT), besting two other nominees -- Krasnoyarsk City in Russia and Subang Jaya in Malaysia.

This entitles Mandaue City to a feasibility study grant that will determine policy program measures to realize its targets for green technology opportunities, particularly in buildings, urban planning, and transport sector. Mandaue City was chosen

as the newest LCMT for having a clear target for reducing its carbon dioxide emissions and for crafting measures to establish a sustainable city to address air pollution and traffic con-

Its proposed project consists of developing green growth areas and interconnecting these areas within Metro Cebu. An ordinance will also be proposed to promote disaster-resilient buildings in the city.

The LCMT project of the APEC Energy Working Group (EWG), launched in 2010, is part of the APEC's Green Growth initiative, which involves upgrading policy initiatives; expanding capacity building and public-private teamwork to promote green industries through finance, trade promotion, green jobs education and training; and

facilitating the development and spread of green technol-

In 2011, the Yujiapu financial district in Tianjin, China was chosen as the test case for the LCMT project. Other previous winners include the city of Da Nang in Vietnam, which implemented an innovative system of electric motorbikes and charging facilities.

Samui Island in Thailand also got support for its feasibility study to utilize solar, wind and small hydropower; for its reliance on electric vehicles; and for its reforestation efforts and protection of existing forests.

The island also adopted green technologies for resort and hotel developments, such as solar water heaters, solar panels on rooftops, biomass power generation of kitchen waste, and increased ventilation for natural cooling.

United Nations Affirms Appointment of Drilon honors Joker Arroyo's "exceptional Filipino Auditor as Oversight Chief

The United Nations General Assembly today unanimously approved the appointment by UN Secretary General Ban Ki-Moon of COA Commissioner Heidi S. Mendoza as Under-Secretary General of the UN's Office of Internal Oversight Services (OIOS).

Ms. Mendoza is the first Filipino ever to be appointed as Under-Secretary General in the UN Secretariat.

Ambassador Lourdes O. Yparraguirre, Permanent Representative of the Philippines to the UN, welcomed the appointment and thanked the regional groups of the UN for their endorsement and the Member States for their affirmation of the appointment. Under UN rules, the appointment by the Secretary General is submitted to the General Assembly for approval.

Ambassador Yparraguirre said, "It is a great honor for the Philippines that a highly-qualified woman from the developing world was chosen to serve in a senior position in the United Nations." She added that Commissioner Mendoza's "qualifications and wealth of experience, coupled with her commitment to excellence and integrity, make her a wise choice for the job. Her qualifications are crucial at this juncture in the history of the UN which is celebrating its 70th anniversary, moving forward with an ambitious 2030 Agenda for Sustainable Development, and pursuing a platform of reforms in various fields of UN work."

She also stressed that "good governance, rule of law, and effective, accountable and transparent institutions within the UN itself are necessary for ensuring that the UN continues to be a credible champion in the global fight against corruption and achieves its lofty goals."

The United States and the Nordic countries of Denmark, Finland, Iceland, Norway and Sweden also hailed the appointment. Speaking on behalf of the United States, Ambassador Isobel Coleman, Ambassador for UN Management and Reform, said that they "look forward to working with Ms. Mendoza" and are "committed to ensuring a strong OIOS to carry out robust audits and effective investigations to ferret out waste, fraud and corruption."

In a similar vein, Sweden, speaking for the Nordic countries, said they "are confident that Ms. Mendoza will lead the OIOS effectively and efficiently" and noted that "an operationally independent OIOS is key to ... rebuilding the confidence among the Member States that the office can play its role in protecting the integrity of the United Nations and promoting accountability within the organization."

Earlier, Secretary of Foreign Affairs Albert F. del Rosario hailed the announcement of the UN Secretary General's intention to appoint Ms. Mendoza, saying that "the appointment of Ms. Heidi Mendoza as UN Under-Secretary-General of an important office. that aims to be an agent of change to promote responsible, accountable, and transparent administration of UN resources, is a true testament of her skills and integrity as a public accountant.

Ms. Mendoza is expected to begin her term on 15 November 2015. As per UN regulations, her appointment is for a fixed term of five years without renewal. As the UN's Under-Secretary General for Internal Oversight, she will be responsible over the resources and staff of the organization through internal audit, monitoring, inspection, evaluation and

Manila RTC orders Sulpicio to pay Php 242 M to families of victims of M/V Princess of the Star sea mishap

MANILA -A Manila Regional Trial Court (RTC) has ordered the former Sulpicio Lines, Inc.'s, now Philippine Span Asia Carrier Corp. (PSACC), to pay Php 241.7 million in damages to the families of the victims of the sinking of its M/V Princess of the Stars at the height of Typhoon Frank on June 21, 2008.

Public Attorney's Office (PAO) Chief Atty. Persida

V. Rueda-Acosta, lawyer of the victims, has shown to the media the 87-page decision dated Sept. 18, 2015 of the Manila RTC Branch 49, which ruled in favor of Celerna Calayag, et al., victims and heirs of the victims of the tragedy.

M/V Princess of the Stars sailed for for Cebu from the Port of Manila on June 20, 2008 with 849 individuals, 709 of whom were passengers, 29 contractors and 111 crew members.

It capsized in the Sibuyan Sea at 21:30 p.m. the next day and only 32 people survived; 227 died and 592 were reported missing.

The RTC ruled that Calayag and the other victims were able to prove by preponderance of evidence the negligence of Sulpicio Lines/PSACC, owned by the Go family, namely Enrique S. Go, Eusebio S. Go, Carlos S. Go, Victoriano S. Go, Dominador S. Go, Ricardo S. Go, Edward S. Go, and Edgar S. Go.

Wherefore, judgement is hereby rendered in favor of the plaintiffs and against the defendants Sulpicio Lines, Inc.(now Philippine Span Asia Carrier Corporation), Enrique S. Go, Eusebio S. Go, Ĉarlos S. Go, Victoriano S. Go. Dominador S. Go, Ricardo S. Go, Edward S. Go, and Edgar S. Go, ordering them to pay jointly

Sara's hashtags posted on her Instagram account are: 'Nagpa upaw nalang ko samtang naghulat (I have shaven while waiting). #Duterte2016. #kalboparasapagbabago (shaven for change). #NohairWecare bisan walay kwarta, bisan way makinarya, bisan mapildi (even without money, even without machinery, even if we lose). #justDUit," earned

In her Instagram post the previous day (October 13), Sara posted the following hashtags "indaysaradutertesending #goodvibes to #Digong #Duterte2016 #pussyfooting."

Joining the skinhead trend are Duterte's executive assistant Lawrence "Bong" Go, Councilors Al Ryan Alejandre and Danilo Dayanghirang.

Alejandre also confirmed barangay captains and other incumbent and former councilors will sport the new hairstyle. They are Councilors Louie John Bonguyan, Bong Advincula, Bernie Al-ag, Karlo Bello, and former councilor

Go confirmed in a text message he shaved his hair in support to a possible presidential bid of Mayor Duterte.

In his Facebook account, Go posted his photo having a shaven head with a caption: "Getting ready for filing of my boss. Hoping for a miracle. Thanks to all."

Alejandre said they shaved their hair as last ditch effort

to encourage Duterte to run for president in next year's elections.

Alejandre said they are inspired by Sara, who is beautiful in her skinhead style. He said they decided to shave their hair in the hope that "the mayor will change his mind and run, considering that there's still two days left to end the filing of CoC". Alejandre, who last shaved off his hair in high school, said their actions also signify concurrence with Sara's campaign #KalboParasaPagbabago.

"What Inday did was not simple. We do this for the country and we will do everything to convince the mayor," he said.

Dayanghirang said that he cut his hair to inform the public that they want change. But he said it is fine with them

whatever the decision of the mayor will be. Meanwhile, Sara's Instagram followers took her posts and hashtags as a good sign that there is still a chance for Duterte to run for president.

Earlier, Duterte said he was not inclined to seek the highest post in the country. He cited Sara's opposition to it and even read his daughter's letter telling him not to run for president because he does not owe anybody anything and that he has done enough for the country.

Some sources said Sara was amused that his father did not read her entire letter. She even answered a netizen's comment calling her selfish with regard her father's presidential bid.

BIR files Php312.14-M tax

The Office of the Ombudsman (Ombudsman) Wednesday filed charges before the Sandiganbayan against Taguig City Mayor Lani Cayetano for allegedly conspiring with another city official to prevent the city council from holding session in August 2010.

In the case filed before the Sandiganbayan, the Ombudsman also charged then Officer-in-Charge City Administrator Jose Luis Montales for violation of Article 143 of the Revised Penal Code (RPC).

The Ombudsman recommended bail at Php12,000 for each of the respondents.

In a resolution, the Ombudsman found probable cause that Cayetano and Montales violated Article 143 of the RPC by allegedly ordering the city hall's personnel to padlock the session hall in time for the maiden assembly of the City Council or Sangguniang Panglungsod (SP) in August 2010.

Article 143 of the RPC penalizes persons who, "by force or fraud, prevent or tend to prevent the meetings of local legislative bodies."

UK is the second-leading destination in the world for foreign direct investments in the Information and Communications Technology (ICT) — only next to the US.

Its ICT sector contributed around 7% to the UK's gross value added (GVA) in 2013.

Global spending on telecoms service, according to British Embassy Manila, is projected to reach £1.64 trillion (\$2.54 trillion) by the end of 2015.

The UK government is committed to leading the development of 5G mobile technology, British Embassy Manila said in a document given to reporters.

"This will double the contribution to the UK economy of spectrum (the airwaves over which all wireless communications devices communicate) to £100 billion (\$154.90 billion) by 2025," the document read.

Seeking partnerships

Two of the British firms visiting the country hope to secure partnerships with Globe or PLDT.

For Kurian Manjakkal, vice-president of Cambridge Broadband Networks, "[the] Philippines is a good investment destination because of its geographical location and population."

"Particularly, we are looking at providing infrastructure for the telecom sector at a much lower rate - mainly linking offices, cell towers through microwave technology," the Cambridge Broadband Networks said.

and severally," the RTC ruling said.

The RTC ordered Sulpicio and the Go family to pay a total of Php241,761,256.34, which include the Php230,248,815.56 damages plus Php 11,512,440.78 worth of attorneys fees.

The victims were able to establish that there was a contract of carriage between the passengers and the said shipping line, as proven by the Passenger's Manifest and by the Releases and Quitclaims which serve as express admission on the part of Sulpicio/PSACC that the recipients of the amounts covered therein were victims and survivors of the said tragedy.

"In these cases, the plaintiffs presented evidence to prove that their loved ones had the earning capacity. There has already been a computation submitted by the parties as contained in their individual complaint. However, this court, guided by prevailing jurisprudence, rules that in the computation of the loss of earning capacity of the deceased relatives of the plaintiffs, the amount of 50-percent must be deducted from the same, to arrive at the net earning capacity," the RTC ruling said.

Manilla, Philippines – Much has been said and reported about Grace Poe as a senator, politician, and even as an adopted daughter. But what else don't you know about the presidential polls front-runner?

Rappler compiled this list from the senator's previous interviews, news articles, and stories from family and friends.

Check which of the 15 things below you do not yet know about Poe:

1. Senator Grace Poe wears white in most occasions. This has been her trademark since the 2013 campaign – a habit which originated from her father, the late action star, Fernando Poe Jr during the 2004 campaign. Asked how many white polo shirts she has, Poe said she currently has 10 that fit her. While people give her white shirts, she said these no longer fit her. Even her gowns in the State of the Nation Addresses are white. The sports utility vehicle she uses every day is also white.

2. Poe starred in movies with FPJ when she was a kid. She was the daughter of Paquito Diaz in the film Durugin si Totoy Bato and was one of the kids in the neighborhood of Max Alvarado in Dugo ng Bayan. She said her parents did not really encourage her because they wanted her to finish her studies.

In Durugin si Totoy Bato, Poe said veteran actor Diaz was the blind character but she thought it was she who was supposed to act blind the whole time.

"Akala ko ako ang bulag sa role, yun pala si Paquito. (I thought I should be blind in my role, but it turned out it should be Paquito.) Many years after we were still laughing about it. Miscommunication," Poe told Rappler.

3. Despite her fine demeanor, Poe was into sports when she was a kid. She was a black belter in taekwondo and a tennis player. She also loved the outdoors.

4. Poe has two half-siblings sired by her father: Ronian Poe, born to actress Ana Mari, and celebrity Lovi Poe, born to model Rowena Moran. She said she first met Lovi during the wake of FPJ. Since then, they have come to know each other better.

5. She got married at the age of 22 right after college over FPJ's opposition. FPJ wanted her to have a career first but Poe decided to leave everything for her husband, whom she met when she was 14 years old.

6. In school, she was active in extracur-

ricular activities. She was a debater in high school at Assumption College, chairperson of the UP Manila College freshman assembly, and a co-founder of the Filipino Cultural Club at Boston College, where she earned her Bachelor of Arts degree major in Political Science.

7. Poe, in a Pep.ph interview, said she finds planting and landscaping therapeutic.

8. While in the US, she worked as a preschool teacher for 3 years at the Montessori School of Cedar Lane. She later worked as a procurement liaison with the United States Geological Survey in 1998. From 2001 until 2004 before she came back to the Philippines, she was a product manager for CSC Scientific, a local company producing scientific equipment.

9. Poe at the age of 47 has 3 kids – Brian, 23, Hanna, 17, and Anika, 11. All her kids are citizens of both the US and the Philippines.

10. Poe is a believer of feng shui, a Chinese Practice. She believes in ghost months and Mercury retrogrades. A feng shui master, a source said, approved the date of her proclamation. When asked, Poe said: "Feng Shui is about the proper positioning of things to harness positive energy. But my mom (Susan Roces) said that the best Feng Shui is to do good and help others."

11. Poe loves to read: she has read all the books of David Baldacci, who, she said in an interview, is her favorite author.

12. In July this year, Poe thought talent manager and columnist Lolit Solis' designer Prada bag is an ecobag. The senator called Solis and apologized for the mistake, saying she really is not familiar with designer bags. Solis, on the other hand, shrugged it off and found the incident funny.

"It was a nice bag naman being fair. I was just not conscious of the brand," Poe told Rappler.

13. Poe, the topnotcher in the 2013 senatorial race, spent P123,605,341.27 during her campaign, based on her statement of expenses and expenditures submitted to the Commission on Elections. Since she got 20,337,327 million votes in 2013, this translates to P6.07 spent per voter.

14. It was during her watch as MTRCB chair that the new classification of TV and movie ratings was implemented.

TV: GP (general patronage), PG (parental

guidance), and SPG (strict parental guidance) became classifications for local TV.

Movies: GP (general patronage), PG (parental guidance), R-13 (restricted to audiences 13 years old and below), R-16 (restricted to audiences 16 years old and below), and R-18 (restricted to audiences 18 years old and below) were applied.


