# Guam Installs First Female Postmaster Man Admits to Marriage Fraud

master is now in the

Tammy Flores Garman Schoenen has been installed as the Guam postmaster at a special invitation-only program at the John Pangelinan Gerber Barrigada Post Office, October 21.

The brief installation program featured remarks by Honolulu-based USPS District Manager Greg Wolny and Manager, Post Office Operations Felix Bagoyo. It culminated in the administration of the Postmaster's Oath of Office to Schoenen by Bagoyo.

Schoenen is the 15th official Guam postmaster in the 113-year history of the office, and the very first female to serve in the position. She has lived in Guam since the age of 2, and has deep roots in the community and a family history of federal service. Schoenen is a graduate of the Academy of Our Lady of Guam and attended the University of Guam.

"I'm proud and honored to be the first female Guam postmaster," said Schoenen. My goal is to provide the best possible service to this community. As a local myself, I'm very much aware of the importance of the Postal Service to Guam's residents and business community.

"I also hope to serve as an example and to pave the way for more local people to reach for and achieve positions of leadership in the Postal Service and other federal agencies," Schoenen

As Guam postmaster, Schoenen supervises 106 postal employees at the Barrigada Main Postal Facility and the Hagatna, Andersen AFB, Naval Station and Tamuning postal facilities and oversees the operations of the Agat, Dededo, Inajaran, Merizo, University of Guam and Yigo Contract Postal Units. She is responsible for the daily distribution of an average of 125,000 pieces of mail to more than 19,000 addresses

on 21 delivery routes and to more than 26,000 PO Boxes island wide. She also collaborates with Honolulu-based USPS officials in the management of the Postal Service's complex and challenging Pacific Islands transportation network.

Schoenen replaced former Guam Postmaster Emmanuel Thomas, who transferred to a postal management position in Illinois.

Schoenen began her postal career 20 years ago as a clerk at the Barrigada Main Postal Facility. Prior to her appointment as Guam postmaster, she had served for more than a decade as Customer Services Supervisor at that same office.

"I want to thank District Manager Wolny and Manager of Post Office Operations Bagoyo for their confidence in me and for their ongoing support and guidance. I also want to thank my postal mentors: my former Supervisor Teddy Taijeron, and former Postmasters Tony

### **Chamorro Land Trust Commission** in Hot Water After Oversight Hearing

✓Commission or CLTC is now in hot water and being questioned following the oversight hearing that was held last October 16, 2015 by Senator Thomas Ada. The Senator's agenda is to ask the CLTC about public property leases that they have recently accommodated. It has raised more queries that led to further investigation putting pressure on CLTC about the huge land property near Lajuna and the Guam International Country Club golf course. The first issue that was

pointed out in the hearing

was the proposed lease of 400 acres of CLTC property close to Lajuna point in Yigo that was leased to an international privately owned construction company named The Smithbridge Group The construction company has been reportedly quarrying the publicly owned land for years under the spose refrahe Everymera State Director for Hawaii and the Western Pacific Mr. Chris Kanazawa, this grant is yes the first-time to the Guam community and that it can be permanent for the coming years from this day on, as long as MCDC meets the USDA's standard or guidelines. Having said, more low-incomed families can also have the chance of having their own homes through continuous partnership of USDA and MCDC, working together with the island's community as reported by local news earlier.

Senator Ada said in a new report that he wants to know how the lease was announced since the CLTC is not authorized to issue any leases until such that the rules and regulations have been adopted by the legislature since the commercial terms of CLTC was voted out by legislature before.

Another subject matter discussed by Senator Ada is the lease of Guam International Country Club golf course that was recently renewed for another 25 years despite of major known issues regarding the contract of lease between the lessor (CLTC) and the lessee.

The lease of the land was first granted during the 1980's with the same lease rate and was renewed recently with the same rent amount and not the current land value.

Ada is questions why despite of unpaid leases and late payment which is prohibited and included in the terms of lease, the contract was renewed by the commission.

"At one point the arrears went up as high as \$800,000 as of the end of the lease term the information that we have is there was still about \$74,000 in arrears in rental payment and about \$52,000 in arrears and tax payments that are due," said Senator Ada during in an interview by local media before the oversight hearing.

It was also later that they found out that the problem is that it's not even clear exactly who the lease holder is and who the lease holder should be, which raised the question

### Lawmaker Revisits Guam Only Visa Senators Surprised at Governor's Waiver for Philippines and Vietnam

Following the announcement (Oct 2) of the US Department of Homeland and Security's creation of a program allowing family members of Filipino and Fil-Am WWII Veterans to receive parole to enter the US, Senator Dennis Rodriguez, Jr. thought is it timely to once again revisit the idea of Guam only visa waiver for Philippines and Vietnam.

"Both these countries are geographically located in close proximity to Guam and have emerged as a powerful economic powerhouse that could provide positive economic and business growth to our island," Rodriguez said in a release.

To support his proposition, Rodriguez, a Filipino decent, wrote Congresswoman Madeleine Bordallo seeking her insights whether "this could finally become a program that would be entertained that would be entertained by the Federal Government at this time."

In her response, Bordallo said "Public Law 110-229, the Consolidated Natural Resources Act of 2008 expanded the Guam visa waiver program and provided the Governor with the authority to petition DHS to include additional countries under our visa waiver program."

Thus, on October 19, Rodriguez Governor Eddie Baza Calvo seeking his support and action. Rodriguez said, "There were various factors that the US Department of Homeland

Security considered in order to determine which countries would be included into the visa waiver program. Among the factors considered in the CNRA is the significant economic

benefit a country provides to Guam or the

At the time of DHS's rulemaking process, Philippines and Vietnam "exhibited high rates of refusal for nonimmigrant visitor's visas as well as an unfavorable potential economic impact to either Guam or CNMI," Rodriguez's letter reads.

But things have changed, claims Rodriguez, stating the Philippines and Vietnam "are now regarded as fast rising economies in the global GDP rankings. In addition, the refusal rates for nonimmigrant visitors from Vietnam have seen a drastic decrease over the years." As for the Philippines, refusal rate remains high, but Rodriguez said "there are positive factors Guam could raise with DHS in a effort to seek inclusion into the visa waiver program. Some of these factors include the potential for future economic and business growth for Guam, the strengthened bilateral relationship, and the Enhanced Defense Cooper-

ation Agreement President Obama signed with the Philippines last year."

As of press time the office of Senator Rodriguez and this paper is yet to receive a comment or response from Adelup as the matter.

Currently, 12 countries are under the Guam-CNMI visa waiver program as follows: Australia, Brunei, Hong Kong, Japan, Malaysia, Nauru, New Zealand, Papua New Guinea, South Korea, Singapore, Taiwan, and United Kingdom. China's VWP is only applicable with CNMI.

It is to be noted that thousands of Filipinos are applying for a non-immigrant visa on a daily basis at the US Embassy in Manila but only a fraction gets approved. This is despite the hefty application fee of a minimum of \$160.00.

Meanwhile, Rodriguez is concerned that the DHS's Oct 2 announcement of the parole program "clearly warns the public that application process to this program

### **Spending of Initial 2015 Savings** The excitement of the availability of funds for

some the Senators' proposed projects was dampened when they learned that Governor Eddie Baza Calvo had already spent the supposed fund.

This developed as former senator Chris Duenas wrote the Rules Committee that the \$1.57 M savings realized from fiscal year 2015 was used to pay the tax refunds.

Seven bills, five authored by Senator Frank Aguon, Jr. and two by Senator Nerissa Underwood, earlier identified the initial 2015 fiscal year savings of \$1.57 million as their source of funds. These bills are:

Bill No. 153-33 (LS) Introduced by Frank Aguon, Jr. with A. Anthony Ada, R.J. Respicio, and Frank Blas, Jr (Appropriation of \$25,000 to the Department of Administration to fund the Fallen Heroes Monument to be erected by the Fallen Heroes of the Pacific Foundation

Bill No. 154-33 (LS) Introduced by Frank Aguon, Jr. with D.G. Rodriguez, Jr. and T.R. Muna Barnes (Appropriation of \$100,000 to the Yona Mayor's Office for the repair of Yona Gym facili-

Muna Barnes (Appropriation of \$150,000 to the Sinajana Mayor's Office for the completion of the open air gymnasium, renovations and reconfiguration of the parking lot, and building of playground.)

Bill No. 182-33 (COR) Introduced by Nerissa B. Underwood (Appropriation of \$250,000 to University of Guam to address the capital outlay needs in anticipation of the WASC visit.)

Bill No. 183-33 (COR) Introduced by Nerissa B. Underwood (Appropria-

tion of \$500,000 to DOE to pay outstanding vendor payments.)

All seven bills are now left hanging as they have no source of funds. The representatives of Adelup, former senator Chris Duenas and DOA Director Anthony Blaz were present during the Legislature's deliberation on Oct. 21 to shed light on the issue. The legislators ended the session day at a stalemate as they have yet to decide on the proper verbiage relative to authorization and appropriation of funds, as Aguon tries to amend his bills.

One thing is clear though, the projects need a while to be implemented.

Adelup, in a press release said that PL 33-60 which paved the way for the subject savings called for the money to be spent on health-related issues. Since there were no bills appropriating the money, "the governor went to the next priority - tax refunds. The savings helped pay for tax refunds; errorfree returns with refunds are paid up to April 28, 2015."/ The Iunction News Team

### Cabras 3 and 4 Fire Damage estimated at around \$100 M

uam Power Authority Jsuffered a massive loss of \$100 million and counting, in total damages caused by the fire and explosion last August 31. This was according to the early reports by GPA General Manager John Benavente, as the power company is about to start its investigation, but this time to assess whether the power transformers can still be salvaged or repaired.

In a press conference the day after the explosion, Benavente said that the GPA is fully.

GPA spokesperson Art Perez already clarified to the local news that the fire is not generation related but is related to the distribution of power and its transmission. He confirmed that no outages are expected as a result of the defective breaker because it was already isolated and put out of service.

According to earlier press release of GPA which was later on supported by the Guam Fire Department, the fire and explosion in Cabras 3 & 4 is purely accidental in

nature. In addition, assistant Fire Chief Joey Manibusan said that they were able to pinpoint that the overheated transformer motor and the oil of the transformer ignited the whole fire which turned into a huge explosion. This was the result of the investigation by the Fire Department led by GFD Chief Joey San Nicolas, though he was not really certain which generator the motor was in since they had limited access inside the power plant in the early stage of the investigation.

GPA General Manager John Benavente said in the initial reports made by the local press, that the power plant where the explosion happened remains to be inaccessible and should be off limits for about 4 months. This is to make way for the structural engineer's assessment on the stability of the whole building structure especially the walls.

The fire that broke out on August 31 affected and somehow weakened the structural components of the power plant building such as continued on page 6

Fortunately, for us taxpayers, the greatest role we can play is to be vigilant and intolerant on perceived to be graft and corrupt practices. We should be willing to denounce and leave our comfort zones for the benefit of the greater good. A vigilant, outspoken, well informed, and active citizenry is the best deterrence to graft and corrupt practices. This Chamorro lady who was educated in the mainland whose name I shall not mention, reminded me that Chamorro culture is not confrontational and that according to her, they know how bad (that bad) certain things are (in terms of shady corrupt deals, etc) although they are not expressing it in public the way some western societies do. However, they as a family or a clan talk about it among themselves and will certainly show their indignation on the coming elections.

A Senator I spoke to also lamented that the current administration has reduced things to near levels of mendicancy for a lot of the have nots.

Another mayor pointed out the very bad road conditions in the villages, in the interiors. If you don't enter into the interiors you may not exactly know the actual road conditions.

Many, many more comments I have heard which I would rather not print for being too brutally frank. Having heard this, my comment is as always, what is happening to the Guam I have spent most of my life in?

At any rate, this columnist within the next couple of months will come to a conclusion on whether or not my fellow Guamanians are ready for a free and vocal press. #### **Dealing with Uncle Sam Leaves Few Options**



More than two decades ago, the US signed the Compact Impact agreement with other islands in the Pacific like Saipan, Chuck, Yap, Marshalls, etc. It stipulates that the inhabitants of these islands could migrate and live in more developed islands like Guam and US mainland in return for the US' use of their islands primarily for military purposes. Whatever Guam spends for accommodating theses islanders, US will pay Guam.

Since then, Guam had already spent more than \$150M and still increasing. But the US paid only a fraction of the amount so far.

Here's an animated dialogue between Uncle Sam and his Chamorro nephew, Juan.

In our community, my Uncle Sam in known as the richest and most influential. One day he approached me saying, "Juan, since you have a bigger house and live close to my Pacific friends, I've offered your services for their boarding and lodging as part of my contract with them. Whatever you spend, just bill me."

Juan: "Uncle, why are they coming to live here? What happened to their homes?"

Sam: "I'm using some of their homes as target practice to test my high-tech weaponry. You know, I can't do this at my homeland because it's too dangerous 'for the statesiders."

"If you say so Uncle, I'm always your obedient nephew."

After almost two decades, Uncle has not given me enough for his guests. Each year, he only gives me a few thousand dollars but it has cost me about \$25,000 yearly for his friends. He now owes me \$150,000. I've been generous and patient long enough; it's time to ask Uncle to pay up.

we've had a mutual self-help housing program for Guam," said Kanazawa in local news interview. "Families will help build their own homes, reducing mortgage costs by up to 30 percent of the market price through sweat equity. This program will provide new opportunities for those wishing to purchase homes." he added.

News release by the USDA said that 20 middle-class families and below can now finally avail of their own homes through the mutual self-help program of USDA and the MCDC as this is especially made for all of them who qualify under the program. These families are also those that are not able to get a mortgage approval from financial institutions and other conventional financing firms.

It will also open the doors of better opportunities to the island community people, by creating six (6) direct and ten (10) indirect jobs during the project through construction

because there are divisions within the department that are shielded from scrutiny because the Organic Act provides that certain documents may be inspected only by the Governor or their designee.

"I commend Governor Calvo for recognizing the importance of fighting corruption and the need to ensure the integrity of the Department of Revenue and Taxation," said San Nicolas. "The fair and just enforcement of our laws is vital to the public trust and we need to verify the incorruptibility of our tax collection and enforcement processes, it must not be shielded from scrutiny when other divisions in the department are being investigated," San Nicolas added.

"Tens of millions of dollars go uncollected every year, with some taxpayers receiving multiple abatements, erasing their total tax due by millions of dollars. These abatements are secret and are cannot be audited for integrity except by the Governor or his designee. As part of his comprehensive investigation into the possibility of corruption in Rev & Tax, I am asking the Governor to authorize the Attorney General to act as an independent investigator and prosecutor to audit collections and enforcement at Rev & Tax or to seek an audit from a federal authority like the Internal Revenue Service," writes San Nicolas.

It is to be noted that the Governor is the Tax Commissioner, and as such, he is the only one who has the authority to examine and investigate corruption within Rev & Tax.

It has also been one year since \$167,000 in taxpayer payments, \$18,000 of it in cash, was stolen from a safe within

the collections branch of the Department of Revenue and Taxation. After questioning several employees about the theft, there has still been no arrest made in the case.

Just last week, Francisco R. Santos was sentenced to a year of imprisonment and was made to pay restitution in the amount of \$343,950 plus a fine of \$22,500. It was said that Santos has not been paying his taxes for 19 years, but he only pled guilty for the 3-year (2010, 2011, and 2012) tax offense even if he was indicted for a 5-year offense. It was said that Santos can no longer be prosecuted for years 2008 and 2009 even if there are evidences of tax offense against him for those years because the prescription period has already lapsed.

And while Prosecutor Joseph McDonald pushed for 3-year imprisonment, the court decided to be lenient and gave him a 1 year jail sentence instead.

Santos was able to get people to rally behind him (including public officials) and give letters of support to the court, stating among others that he is good man and that he is remorseful of his crimes.

The people of Guam, however, are not happy with the court decision. They say that while Santos may be a good man, he violated the tax law which every Guamanian is trying to comply with. Some cited that their meager tax refunds are even being garnished as payment for their financial obligations with the government. A lot is questioning the equal applicability of the law.

Santos is a high-paid consultant of the Guam International Airport. Despite his indictment, his contract with the airport was not cancelled. *The Junction News Team*

she went ahead with it, adding she is not violating the law. "And none of them said 'We need that, we need that for the tax refund.' Nobody until the morning that we were deciding as to what bills will go forward did we get a letter from Mr. Duenas who is a Special Assistant to the Governor and say, sorry, we've already used that money. Not even a phone call, not even to say Ma'am, we're going to try to find money for the University of Guam, the \$250,000. We'll work with you, we have an MOU, we'll make it happen." Underwood said she is sorry for the students and professors who have been working so hard to improve UOG.

Underwood will send Bill 182-33 to the committee as there is no money for it. "We were told here by the Administration that they don't have the fund to fix the air conditioning so that our students will be of comfort."

As to 183-33 which is supposed to appropriate \$500,000 for the DOE, this was also sent back to the Committee.

Underwood related that it was not too long ago that Simon Sanchez was almost shut down. She said "they can only clean if they have the supplies; they can only have the supplies if they have the funding."

She said DOE is short of \$5.9 M and additional \$1.2 M of reimbursement. "That is not just payroll, that's about them not being able to save for the contractors for the air conditioning service contract. That's about them not being able to pay the vendors who provide the supplies and materials so that our kids have their crayons to color with, so that kids the books to read with, so that our students have the pencil

to write with. We are now talking about a Department that is building up our generation. But once again, half a million dollars, sorry. Without even giving us a solution how this is going to be met."

She appealed to her colleagues and the Governor of Guam to "please, for goodness' sake, let's walk our talk about putting education first!"

With a cracking voice, Underwood relates the situation to a family in a kitchen table, "when there is only so much to eat, don't we want our children to eat first? Basically what happened here is we were on a kitchen table, and there was extra food that came in, and a member of our family just decided and say, 'I'm sorry we got to send that somewhere else where it's needed,' and our kids are short of food."

In ending, Underwood almost practically begged for her colleagues to "Please make sure that our children eat first, that we protect our children first."

Underwood noted that UOG is short of \$4.5 M, DOE is short of \$6M, and GCC is yet to receive \$6.6M for 2015 fiscal year. Senator Mike San Nicolas confirmed this figure, saying \$19M in total for education for fiscal year 2015 is yet to be delivered. He said it was also uncovered that GMHA was also short of \$24M of Medicaid reimbursement, an additional of \$15.8 M of tax refunds that still have not been paid out, for a total of about \$58 M of promises that were made on 2015 that have yet to be fulfilled.

San Nicolas questioned the priorities of the administration saying that, "Almost a year ago, the administration came down here and said, 'We have more than enough money to pay for raises for elective and appointive officials," only to find out a year later that even the \$1.5 M 2015 initial savings was already drained./The Junction News Team

the beam and columns. GPA's plan is to temporarily put new roofing to the building but they first have to make sure that the walls of the whole structure will be able to hold it securely, earlier reports added.

Another problem that GPA is facing is that the beams and columns are not available in the Island. Benavente said that it has to be ordered and fabricated in other countries and shipped in Guam, and that may take 2-3 months with uncertainty.

"New structural beams are needed to secure the building and for the new temporary roof." says Benavente in an interview with a local daily.

GPA also mentioned that the explosion of Cabras 3 & 4 might have totally destroyed one of the plants beyond repair and the cost of building (the power plant) from its foundation and up is somewhere around \$300 million 20 years ago.

"We are bringing back everything we can; trying to get as much as we can from every machine," Benavente said in a local news.

It was also said that the demand of power consumption in the entire island should be at least around 252-255 megawatts on peak hours. The explosion in Cabras 3 & 4 cut the power supply to about 79 megawatts and combined together, the two plants had a maximum capacity of power generated of 74 megawatts according to GPA. This is aside from the possibility of losing one plant that would be really a huge cost for the GPA to shoulder.

A quick glance or preliminary assessment of the damaged Cabras 3, GPA said earlier that it is still repairable and that it could take at least six months to fix it. Cabras 4 on the other hand, have sustained the more extensive damage and the GPA could be looking of at least one year for it to be rehabilitated or worse the repair could not be possible anymore./ *The Junction News Team*

"We had to ask the question who is the tenant now because the signatures on the documents are very different so if in fact there was a sale or a change or an assignment of the lease, the lease is very clear that would require the approval of the governor and the legislature and I'm certainly not aware and so we requested the documentation to find out if in fact there's been a change of hands," reports another daily.

It was also said during the hearing, that the golf course was supposed to be monitoring wells use to test the water safety and ensure that their fertilizers are not contaminating the northern aquifer of which they haven't provided any water reports yet.

# Husband and Wife Tandem Bribed Dishonest and Corrupt Public Officials

A Dededo husband and wife tandem who are business owners had involved themselves in illegal activities such as smuggling and bribery together with corrupt public officials of Guam Customs and Quarantine Agency or GCQA and Department of Revenue and Taxation Alcohol and Beverage Control for many years.

The couple, identified as Ruel Valencia and Lydia Valencia, were mentioned in the sworn statements of defendants and the indictment filed before the District Court of Guam.

The Indictment names 7 public government officials who pled guilty of their respective federal charges.

According to the documents from the court, the couple admittedly said that they had given cash, airline tickets, and other material goods as bribes or cash rewards to the disposed public officials for favorable illegal deals. The public officials and officers involved in the crime are:

Henry Alvendia and Frank Cruz, b o t h

Lieutenant of GCQA; Jesus Paulino, Tommie Pablo, Glen Crisostomo all three are Customs officer with GCQA; John Garrido and Gerald Salas Compliance Officer Alcohol and Beverage Control of Department of Rev and Tax.

The other three civilians associated in the bribery and smuggling charges are Al Kenneth Constantino, Becky Cruz, and Ruel Valencia.

The ten are scheduled for their hearing in January and February of next year.

The tandem couple are both from the Philippines and owners of JUNVI Corporation that operates three local businesses in Dededo - the Valencia Wholesale and Retail, Valencia Check Cashing Services, and Cabalen Fastfood Corporation.

Court documents show that Ruel Valencia gave a total amount of \$37,000 of cash and other things of value such as food and goods to the agents involved, intending to influence and reward them for a transaction or series of transaction



The alleged bribe given by the Valencia couple was for the federal agent's "Harddays-work" in allowing containers to be unloaded in Guam illegally and free of taxes. The containers were documented to have come from the Philippines, (where the Valencia couple came from) that mostly contains booze or liquor, cigarettes, lighters, bags and other merchandise knock-offs'. These merchandise will be later available in Valencia Wholesale and Retail store, a business owned by the couple in Dededo.

The 10 defendants signed a plea-guilty agreement under the federal law of Guam.

Valencia who were indicted separately also pled guilty also of "bribing an agent concerning a program receiving federal funds," according to court documents. All other offenders involved have also admitted conspiracy to defraud and to deprive honest services, according to their signed plea-guilty agreements./The Junction News Team

# The Doctor is In - Dr. Dante Garcia

 ${f F}$  or someone to inspire other people, he or she does not have to be an achiever with numerous plaques or recognition, nor a recipient of countless awards. Someone doesn't have to be excellent when it comes to education and profes-

sional work. Wealth in life should also not be of measure, as it can only get someone as far as the eye can see.

We've featured our "Pinoy kababayans" here in our Galing Pinoy section in the past of who had really made it to the top that made an impact to everyone's lives. Great people working in the private and public sector that became an inspiration to many Pinoys on Guam.

But what are the criteria for someone to be a real inspira-

tion to others? If you have a list of these criteria, perhaps, you are missing the point, because actually there is none.

Today I'll be the instrument to inspire somebody by writing a story of inspiration to few, and the "Noypi" attitude at its simplest form.

#### Meet Dr. Garcia

Dr. Dante Garcia is your neighbor optometrist who has been living on Guam for many years now. In fact, he and his family have been living on Guam since 1985 when they migrated to find new hope of seeing greener pastures like everybody else. It has been 30 years back, and how he remembers starting small when he and his family arrived

Living in a foreign country for the first time with unfamiliar territories, he began to work his way up to the level of his dreams, as in just after 5 years he opened

his own optical clinic, not just one but two of them, the Garcia Optical. One in Tamuning and the other in Dededo which he had acquired through hard-work and dedication through his own steam.

#### His Pinoy Heritage

Dr. Dante Garcia came from a very simple, quiet middle-class family in the Philippines. An "Uragon" from the Bicol Province of the Philippines and like any ordinary "Pinoy" the Doctor loves Adobong Baboy, Squid, Shrimp, and Chicken dishes spicy! Just like any other typical Pinoy.

#### His Education and His Family Values

To become a God-fearing person, one must have to practice his faith and it begins inside our own homes with our family. Dr. Garcia made it a point to serve his obligation on his faith.

His obedience led to his becoming who he is today and said during my written interview with him that "I was just an obedient child, followed my Mom's decision to take up Optometry, since she was a very lucrative profession."

In college, he had done nothing extra ordinary, just finishing his school with high grades and on time at the Centro Escolar University in Manila, making it to the list of Batch 1976 graduates.

#### **Starting With Small Capital**

"I started very small, very little capital afforded by my parents, it was just a small Optical Clinic at the corner of

> our house in Quezon City. I thought it was better than being employed and could earn more by being self employed. I also did Optometry Field Work and servicing different companies during that time. I serviced about 60 companies which proved to be a money maker. I was able to build up capital and savings. I bought a new taxi, hired two drivers and it produced good income. I sold everything when my wife

and I immigrated to Guam." This is the good doctor's reply when asked about how he started his business after college. As his family is very supportive of him and his other siblings which is the traditional Filipino-true-value.

#### Life on Guam

His life on Guam is the continuation of his very low-profile life that just got better by having his own family to take care of. His upbringing, simplified-quality way of life, values, faith and positive vibes that invites goodness in everything he does in life.

In fact, when asked about his disappointments in life, he said "Nothing of great disappointment, maybe I could have wished for 2 more children." Notice how he transformed the statement

of disappointment in to being thankful for what he already

It is positivity all the way as I tried to squeeze out "the badness" in him; it's just too much of his positive vibe that comes out of him. Leaving me to ask myself "Did I just get schooled?"

#### Life Begins at 60

At the age of 60, for Dr. Garcia, it is all about enjoying the fruits of his labor as he just loves traveling, touring many places in the world, scuba diving in Guam, Philippines, Palau and many other countries.

"I may not physically look like it, but I'm 60 yrs. old now so.....just relax and coast along in a snowballing success. To liquidate prop-

erties and simplify life and to be as stress free as possible, just stick and maintain what I am good at, to enjoy and make use of the fruits of my labor, to be concerned about healthful living."-Dr. Dante Garcia's reply when asked about his future



cussions about measures to develop and implement water demand management strategies and policies. Key topics include labeling water fixtures, reusing treated water for agriculture, building reservoirs, and education and behavior change related to water efficiency and conservation. USAID is holding similar events in Iloilo and Zamboanga to share with local decision makers options that reduce water demand, improve management, and increase water security. Iloilo and Zamboanga are key cities under USAID's Cities Development Initiative, a partnership within the bilateral Partnership for Growth, which spurs secondary cities to become regional growth hubs.

As part of the water demand management forum on October 23, USAID will also launch the Water Alliance. The Water Alliance is a partnership between USAID, the Philippine Business for Social Progress, and businesses that are committed to creating solutions to water security challenges in the Philippines./US Embassy, Manila

### US Government Brings Water Demand Management Expertise to the Philippines

Manila - The U.S. Embassy Manila's United States Agency for International Development (USAID) is launching a series of fora on "Coping with El Niño and Climate Change" to present water demand management as a viable option for addressing water security concerns.

Three national fora will be held in Manila with key decision makers from across the Philippines:

October 20: Water Demand Management Forum for Government Policy Makers

October 21: Water Demand Management Forum for the Social Sector

October 23: Water Demand Management Forum for the Business Sector and Launch of the Water Alliance

The country is already experiencing water shortages, which are expected to continue into 2016. Furthermore, according to the Philippine Atmospheric, Geophysical

and Astronomical Services Administration, the Philippines is bracing for possibly the strongest El Niño event in history. Climate change is also projected to affect the water supply throughout the country.

"Given the increasing demand for water and its declining availability, water demand management is the vital next step, so vital, that it is now a target of the newly approved United Nations' Sustainable Development Goals," said USAID Mission Director Dr. Susan Brems. "We look forward to working with the government of the Philippines to achieve these new goals and ensure that the Philippines is better prepared to face water shortages from this El Niño event and future impacts of climate change."

The U.S. government, through USAID's Water Security for Resilient Economic Growth Project, is bringing international water demand management experts to the Philippines to share their expertise with government officials and members of civil society and the private sector. These experts include: Ms. Maysoon Zoubi, former Secretary General of

the Ministry of Water and Irrigation for Jordan; Dr. Stuart White, Director of the Institute for Sustainable Futures, University of Technology, Sydney, Australia; and Ms. Mary Ann Dickinson, President and CEO, Alliance for Water Efficiency, California, USA. With Australia and California currently experiencing their sixth year of drought, and with Jordan being a water-stressed country, these experts' experiences and knowledge are very relevant for the Philippines.

#### The Leyte Landing

FROM THE PRESIDENTIAL MUSEUM AND LIBRARY

On October 20, we celebrate the return of the United States Forces, led by Philippine Field Marshal Douglas MacArthur, to the Philippines. The Leyte Landing was a pivotal moment in Philippine hisotry that led to the liberation of the country from Japanese forces, ending three years of Japanese occupation.

The landing also marked the re-establishment of the Commonwealth Government on Philippine soil after years of government-in-exile in Washington, D.C.

### Respect Miriam's right to privacy— Sen. Bongbong Marcos'

Miriam Santiago's right to privacy should be respected.

Earlier, Santiago invoked her right to privacy in rejecting a doctor's request to release her medical records. Dr. Sylvia Estrada Claudio said the lady senator should bare such records to prove she is fit for the presidency.

"Ako, pagka sinabi niya na kaya niya ang mangampanya, na magaling na siya, edi sino pa ba paniniwalaan ko kung hindi si Senator Miriam," said Marcos in an interview at GMA-7's morning show "Unang Hirit".

Before filing her certificate of candidacy to run as President in the 2016 elections Santiago declared that she had won her bout with cancer.

Santiago later named Sen. Marcos as her choice for vice

presidential running mate.

According to Marcos talks are still on-going between his camp and Santiago to discuss the details of their alliance.

"Mabuti naman ang takbo ng usapan namin dahil ang ginagawa namin ay we are forming a loose coalition sa aming mga kampo," said Marcos.

### VP BINAY VOWS AID TO TYPHOON-AFFECTED FAMILIES

Vice President Jejomar C. Binay Wednesday visited flooded towns in Pampanga, Nueva Ecija, and Bulacan as his office continued to provide relief and other assistance to families displaced by typhoon Lando.

Binay visited San Simon, Candaba, and Arayat in Pampanga; Cabiao, San Isidro, and Gapan in Nueva Ecija; San Miguel, and San Ildefonso in Bulacan.

He talked with local leaders to know the needs of the affected residents and what assistance his office could give them. Aside from relief goods, local officials requested hybrid rice seedlings from the Vice President to replace damaged crops.

The Vice President said his office will provide relief goods and seedlings.

So far, the Office of the Vice President (OVP) has delivered 9,500 packs of relief goods in Nueva Ecija, 5,000 in Isabela, 4,600 in Bulacan, 2,400 in Pampanga, 4,500 in Pangasinan, 3,200 in Tarlac, 3,000 in Quirino, 3,000 in Nueva Vizcaya, and 5,000 in Aurora.

According to the National Disaster Risk Reduction and Management Council, Typhoon Lando has claimed 26 lives and inflicted around P6 million-worth of damage to the agriculture sector

On Tuesday, Binay visited the towns of Gerona and Pura in Tarlac; and Guimba, Cabanatuan City, Bongabon, and Licab in Nueva Ecija. He is scheduled to go to Isabela, his mother's home province, October 22.

#### Cayetano: let's push for real change, bring down tax rates for working Filipinos now

Senate Majority Leader Alan Peter Cayetano expressed full support for calls to reform the country's decades-old income tax brackets.

Speaking in front of reporters in a media forum in Kamuning, Quezon City on Wednesday, Cayetano said present government officials do not have to wait for the next administration to push for measures that will create real change in people's lives.

"Don't wait for the next seven to eight months bago mag-eleksyon. Pwede namang ngayon pa lang, hamunin na ang mga kandidato, because almost all candidates [in the 2016 elections] are in government now. On calls to lower tax rates for Filipinos, we can do it now," the senator stressed.

Cayetano had been urging the Aquino administration to work on the immediate passage of tax reform bills pending in Congress that seek to lower the country's income and corporate tax rates.

He cited an earlier statement by Steve Forbes, chairman and editor-inchief of Forbes Media. In an interview at the sidelines of the 15th Forbes Global CEO Conference held here last October 12, Forbes indicated that the Philippine government may consider slashing corporate and income tax rates without the risk of losing revenues.

"I'm hoping that the current administration will study and reconsider this proposal for the benefit of the middle class and of the poor. If we want real change and inclusive growth to happen, we need to pass measures that will directly benefit the people," he concluded.

### Sen. Marcos says he'd like to help create more jobs

Given the opportunity in 2016 to serve the country as Vice President, Sen. Bongbong Marcos, Jr. said he'd like to focus his efforts on job creation.

In an interview in the morning TV show "Unang Hirit" on Wednesday Marcos said that if the next President would ask his choice Cabinet portfolio, he would choose DOLE.

"Siguro kung mayroon akong hihingin na portfolio, palagay ko gusto kong makatulong sa DOLE," Marcos said.

He noted that one of the

biggest problems facing the country today is lack of jobs.

Citing statistics saying that 90 % of jobs come from the private sector, Marcos said the government's job should be to lay down the enabling environment to encourage growth of the private sector.

In particular, Marcos said the government should focus on SME's which is the biggest contributor to the country's economy.

Among others, Marcos said the government should embark on business-driven infrastructures, lead in the research and development,

provide appropriate training, as well as access to credit facilities.

"Maraming maaaring gawin para tulungan ang sitwasyon sa kakulangan ng trabaho dito sa atin ngayon kaya't kung itatanong sa akin, DOLE siguro, iyon ang uunahin ko," sabi ng senador.

If not DOLE, Marcos said he could opt for DOTC instead. The senator is confident he could contribute towards solving the pressing problems facing the department, including the traffic jams in Metro Manila and lack of public transport.



percent of respondents plan to expand in the Philippines and 67 percent indicated that they expect their workforce to increase in 2015."

The Manila delegation was resolute in their presentations that the Philippines is prepared to unlock its full economic potential. They were unanimous in saying that the Philippine economy not only has a lot to offer today but also has a lot to look forward to in the near future and in the coming decades.

The ASEAN Economic Community, with the Economic Integration meeting happening this year, presents many opportunities for business and investment in the near future.

"ASEAN has a combined nominal GDP of US\$2.4 trillion, and would collectively rank as the world's seventh largest economy. GDP growth for 2015 is forecast by the Asian Development Bank at 5.1 percent. U.S. investment alone in ASEAN was almost \$190 billion in 2012, and growing at an average annual rate of 9 percent. And with a combined population of some 625 million people, its transformation into a single market will unlock a massive amount of economic opportunities," said Ambassador Cuisia.

According to estimates of Dr. Villegas, the Philippines will experience growth rates of 7 to 10 percent in the next decade, which the professor says is a positive result of over 25 years of slow and painful reforms. Citing an HSBC Global Research Report predicting that the country will be the 16th largest economy in the world by 2050, Dr. Villegas also stated that "it is even possible for the Philippines to become a developed country in 20 to 30 years."

"Since our geographic location also puts us at the center of the most dynamic region for the next 50 to 100 years, we can be the gateway of the Pacific to South East Asia, and to greater Asia," said Ambassador Cuisia.

The conference in Pittsburgh is the first leg in a three-city Private Sector-led Investment Roadshow and was made possible with the cooperation of the Philippine Consulate General in New York, Philippine Trade and Investment Center in New York, the Allegheny Conference on Community Development led by Executive Vice President Mr. Bill Flanagan, and the Filipino American Association of Pittsburgh.

Ambassador Cuisia likewise had a meeting with Pittsburgh City Mayor William Peduto and attended a dinner hosted by the Filipino American Association of Pittsburgh.

The delegation will visit Dallas/Fort Worth on October 21 before they head to Seattle for the final leg of the roadshow on October 23. Hours before the incident, Baasen had just turned over his duties as the department head of emergency medicine. Though he was off duty at the time, he made a call to the emergency room when he was informed of the mass casualty. Without hesitation, he headed back to the hospital to assist.

"I remember the day very well like it was yesterday and all the chaos that was going on in the trauma bay and within the emergency department," he said. "It's truly remarkable to see how well he's recovered from this significant degree of injury he suffered."

Though it has been nearly nine years since he last saw Lammey, Bassen said he was glad to know a former patient received the best care.

"It's great to see these stories from a personal standpoint when you see a lot of patients every day," Baasen said. "A lot of times you don't see the end results, especially someone who's seriously injured as he is. To be able to have him come back and thank us personally and for us to see how well he's doing, it makes you understand why you do the job."

of the stress on the grid. Although the housing circuits were affected by the automatic load shedding, they have not been affected during the manual load shedding. Officials with the Consolidated Commission on Utilities, which is the publically elected body in charge of GPA, have said that when manual load shedding is required, the whole island is susceptible to being asked to go without power for an hour or more each time. Fortunately, since the base is already reducing demand on the system with facility generators, Andersen AFB has not been affected.

Meanwhile, crews from the 36th CES have been working around the clock to fix any problems and ensure power is kept running on base. In addition to activating facility generators, the 36th CES has also shut down air conditioning to large industrial facilities or in facilities that are unoccupied when not in use at night.

"We are doing everything we can possibly do to keep the mission going, and have also done our part to free up extra power that can be used on the island," said Master Sgt. Matt Castillo, 36th CES Operations Flight superintendent. "GPA now has more capacity to be used off base."

To alleviate the ongoing power issue, everyone on base can do their part to conserve as much energy as possible, Castillo said.

Coincidentally, October marks Energy Action Month, reminding everyone that individual efforts can make a positive impact, especially during the recent power incident that affected Guam's power grid.

"The highest energy demand times are between 6-10 p.m.," Castillo said. "During this time, island residents can really help out and do their part by avoiding or minimizing the use of any electrical component that produces heat, such as electric stoves, clothes dryers, coffee pots, toasters and water heaters. These small adjustments can benefit the island."

Another easy fix is to turn the thermostat up a few degrees. If you set the temperature in the mid-70s, customers will save energy, money, plus remain comfortable. Base officials have seen power use reduction in base housing; however, more help is needed to alleviate the ongoing shortfall.

"Everyone can do their part," Gingras said. "The entire island needs to be aware of every watt they are consuming. There are things that people can do to adjust their routine that has zero impact on them, but have a huge impact on the island overall."/Airman 1st Class Arielle Vasquez, 36th Wing Public Affairs, AAFB

### Gov't prioritizes speedy delivery of relief supplies to Lando-affected areas

The Department of Social Welfare and Development continues to work with the Armed Forces of the Philippines, the Philippine National Police, and local government units to ensure that those living in areas affected by Typhoon Lando receive food supplies immediately.

According to Department of Social Welfare and Development (DSWD) Secretary Corazon Juliano-Soliman, all DSWD-Field Offices in areas affected by Typhoon Lando continue to repack relief supplies that can be immediately distributed to local government units (LGUs).

Aside from keeping the safety of affected families through continuous evacuation from hazardous areas, the goal of the department is to also ensure that there are enough relief supplies and that these reach the beneficiaries immediately.

The Secretary added that the department has an existing agreement with the Armed Forces of the Philippines, the Philippine National Police, and the Department of Public Works and Highways to ensure the availability of vehicles for transporting goods to the affected areas.

She also mentioned the new mechanized repacking system that the Department has recently acquired

enhances the capacity of the Department to repack 50,000 family food packs per day.

# Andersen technicians combat power shortage, conserve energy

In order to beat the island's heat, Guam residents rely on electric fans, refrigerators and air conditioners on a

daily basis. All of these appliances require energy to ensure everyone's well-being.

Members of Team Andersen were recently reminded how crucial electricity is on the island when Guam Power Authority lost two of its four base load production units due to an explosion toward the end of August. The damaged units were responsible for producing power for the island at all times

Currently, GPA is using generators built to handle times when energy consumption is at its peak to cover the island's needs; however, these generators have been running nearly fulltime since the explosion, said Maj. James

Every little bit helps. Here are some suggestions of high-energy consuming items to use less or not at all during evening hours. Highest power demand times are from 6 - 10 p.m.

Turn your refrigerator down. Refrigerators account for about 20% of household electricity use. Use a thermometer to set your refrigerator temperature as close to 37 degrees and your freezer as close to 3 degrees as possible.

Turn off your water heater when you're not using it. If turning it off is not an option, at least turn down your water heater thermostat. Thermostats are often set to 140 degrees F when 120 is usually fine. Each 10 degree reduction saves 600 pounds of CO2 per year for an least turn of the drying

Gingras, 36th Civil Engineer Squadron Operations Flight commander. Unfortunately, a few times in the last month, technical problems caused several of the generators to trip off line, causing automatic load shedding. That meant certain circuits

were turned off in order to preserve the entire electric grid. Plus, in order to perform normal and emergency repairs to those systems, GPA technicians had to perform manual load shedding, which meant GPA manually switched off electric circuits to avoid overloading the remaining generators on the grid.

Following the automatic load shedding, the 36th CES has been using its own stand-by generators to reduce power consumption on base. Normally, all of the facilities on Andersen AFB are

connected to the commercial power grid, but some were disconnected when the issues arose to relieve some

#### Wounded Warrior Visits Guam, Recalls Excellent USNH Guam Care

Memories of corpsmen administering care to his injured body filled Michael Lammey's mind as he toured U.S. Naval Hospital (USNH) Guam in Agana Heights Oct. 21.

"I was nervous when I first got here because I didn't know how I was going to react emotionally," he said. "But now actually being here I feel proud that I was in the Navy and I'm able to come back here and meet some of the people that were here when I was going through

what I went through."

On Dec. 1, 2006, Lammey and five other Sailors serving aboard the submarine tender USS Frank Cable (AS 40) suffered life-threatening burns when a section of the boiler system split open, emptying steam inside the ship.

ship.
The Sailors were transported to USNH Guam where they received primary treatment before being sent to Brooke Army Medical Center in San Antonio.

"The medical team here


probably saved my life," Lammey said. "For them to do what they did at the old hospital (building) with that type of casualty was amazing. With the limited resources they had there, they had to depend heavily on the staff, and the staff exceeded expectations."

Cmdr. Chad Baasen, USNH Guam director of medical services, was at the hospital the day the accident occurred.
