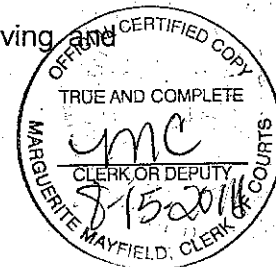

Pursuant to I.C. 14-33 *et seq.*, the undersigned hereby submit their Petition for the Formation of the Lake DeTurk Conservancy District, and in support thereof, state as follows:

1. The name of the proposed conservancy district is the "Lake DeTurk Conservancy District" (hereinafter, the "District").
2. The statutory purposes for with the District is to be established are as follows:
 - a. Developing forests, wildlife areas, parks, and recreational facilities if feasible in connection with beneficial water management, as provided in I.C. 14-33-1-1(6).
 - b. Operation, maintenance, and improvement of a work of improvement for water based recreational purposes including, but not limited to Lake DeTurk and the Lake DeTurk dam and spillway, as provided in I.C. 14-33-1-1(9).
3. The District is necessary to accomplish the above purposes for the following reasons:
 - a. the District territory, including Lake DeTurk and the dam and spillway are located in unincorporated territory.
 - b. an entity is required which is capable and responsible for directly overseeing and carrying out the testing, engineering, repairing, improving and maintaining of Lake DeTurk, the dam and spillway.



4. The territory to be included in the District will include Lake DeTurk, the dam, spillway and appurtenances, all real property adjoining Lake DeTurk and all platted lots in Shireman Estates, a subdivision in the City of Martinsville, which is more particularly described in the "Description of Territory Included in the Lake DeTurk Conservancy District" set forth in Exhibit A, which is attached hereto and made a part hereof.

5. The costs and damages of and to be paid solely by the District for repairing, maintaining and improving Lake DeTurk and appurtenances, the dam and spillway, will probably be less than the benefits received in the District.

6. The creation of the District will be conducive to the public health, safety and welfare of the freeholders and present and future freeholders owning land adjacent to Lake DeTurk.

7. This petition is not conditioned upon either a grant of federal or state funds. Petitioners know of no grants, either state or federal, presently available; however, if such a grant would become available, all conditions would be considered to accomplish the purpose in the most economical manner.

8. Maintenance, repair and operation of the works of improvements necessary for (1) developing forests, wildlife areas, parks and recreational facilities in connection with beneficial water management and, (2) the operation maintenance and improvement of works of improvement including, but not limited to Lake DeTurk the dam and spillway shall, be paid for by both annual levy of special benefit taxes and an annual assessment on land found to be exceptionally benefited; or by another method provided by statute, all as the Court may order in its approval of the District plan.

9. There shall be five (5) directors for the District, each from one of the five (5) areas described in Exhibit B, which is attached hereto and made a part hereof.

10. This petition has been executed in counterparts as provided in I.C. 14-33-2-6 and has been signed by at least 30% of the freeholders in the District as required by I.C. 14-33-2-2. The freeholder signature pages are attached hereto and made a part here of as Exhibit C.

11. Counsel for the District and the organizer of the District in connection in its formation are Ralph M. Foley and Peter R. Foley, FOLEY FOLEY & PEDEN, 60 E. Morgan St., Martinsville, IN 46151.

12. Pursuant to the applicable of statutes, at the time of filing this petition, bond will be posted to pay the cost of notice and all Court cost associated with this proceeding in the event the District is not established or is dismissed.

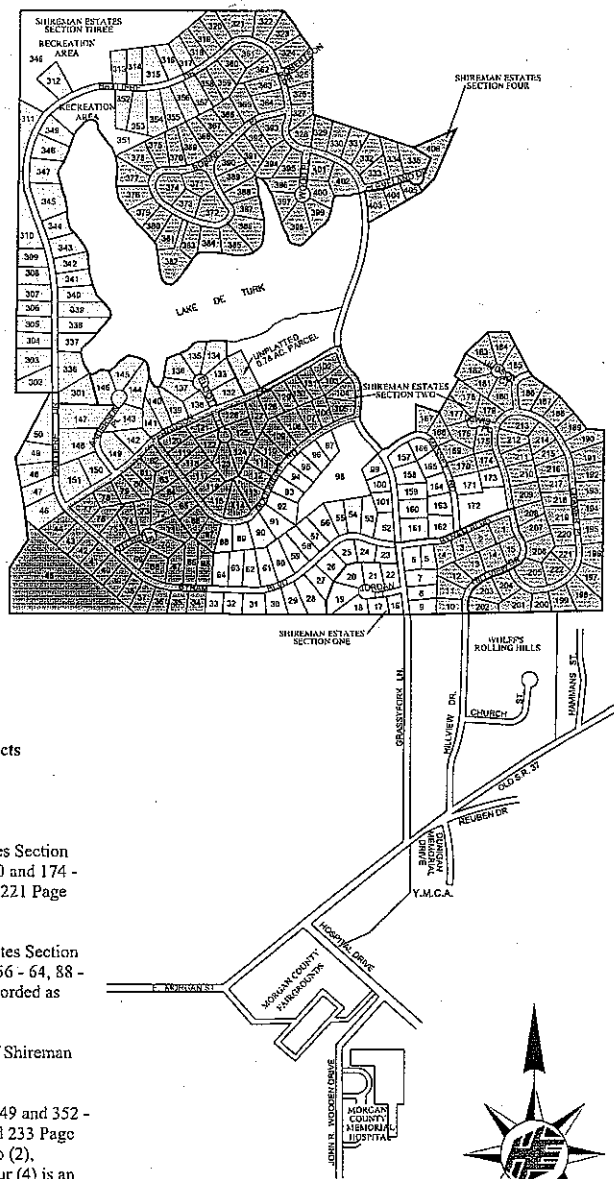
