STERLING MONTAGE CAY

- Formally Matt Lowes Cay
- Joint Venture of Sterling Global Financial and Montage International Hotel Group
- 53 Acre Island
- Mixed-use development comprising marina, hotel, residential, spa, meeting space, fitness and food & beverage space
- 33% of 53 acres developed



PROJECT COMPONENTS

- 46 slip marina
 - Already existing and operational
- 95 Key boutique hotel comprised of villas and guestrooms
 - Hotel Amenities (restaurants, spa, fitness center, meeting facilities)
- 26 Single Family Lots (half acre)
- 6 Over water structures
 - Currently seeking approval
 - Designed to the highest environmental standard. All services will be on land
- Sea Plane Floating Dock & Helipad
- Arrivals Center
 - Will be located in Marsh Harbour
- Back of House Facilities
 - Will be on island as well as Marsh Harbour

ECONOMIC IMPACTS (continued)

- **Construction Phase**
 - 2,970 persons will be hired during this phase.
- **Operational Phase**
 - 250 plus persons
- **Work Permits**
 - Will be requested during and after construction phase, with the goal of limiting the number being requested
